Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used wherever children, pets, non-target mammals, or birds may have access to the bait placement location.


USE RESTRICTIONS: This product may only be used to control the following rodent pests in and around mam-made structures: House mouse (*Mus musculus*), Norway rat (*Rattus norvegicus*), Roof rat (*Rattus rattus*), Cotton rat' (*Sigmodon hispidus*), Eastern harvest mouse' (*Reithnodontomys humul*), Golden mouse' (*Ochnotomys nuttali*), Polynesian rat' (*Rattus exulans*), Meadow vole' (*Microtus pennsylvanicus*), White-throated woodrat' (*Neotoma albigula*), Southern plains woodrat' (*Neotoma micropus*), and Mexican woodrat' (*Neotoma mexicana*). This product must be used in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), dooks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

This product may only be applied to active burrows to control rats within 100 feet of buildings and man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations provided that infestations of these rodents have been confirmed. Efforts should be made to remove food trash, garbage, clutter and debris. Bait must be placed no less than 6 inches into active rat burrows. Do not broadcast bait.

Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. When used in USDA inspected facilities, this product must be applied in tamper-resistant bait stations. Do not use this product in sewers.

Do not sell this product in individual containers holding less than 16 pounds of bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats, mice, or meadow voles' will most likely find and consume bait. Generally, these are along walls, by gnawed openings, in corners and concealed places, between floors or walls, or in locations where rats, mice, or meadow voles', or their signs have been observed. Remove as much alternative food as possible.



APPLICATION DIRECTIONS:

Rats:

Apply 3 to 16 ounces per placement, usually spaced 15 to 30 feet apart. Maintain a constant supply of fresh bait for 10 days or until sions of rat activity cease.

Mice and Meadow Voles*:

Apply 1/4 to 1/2 oz. (1–2 level tablespoons) of bait per placement at 8 to 12 foot intervals. Larger placements (up to 2 oz.) may be needed at points of very high activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse or meadow vole* activity cease.

Follow-up:

Replace contaminated or spoiled bait immediately. Wearing waterproof gloves, collect and properly dispose of all visible dead animals and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. For a continuous infestation, set up permanent bait stations and replenish bait as needed.
